

# Epic Quotes Commercial Lines: Producer Codes Configuration Formats

Our carrier partners require your agency producer codes to link your submissions from Epic Quotes Commercial Lines to their portal. The following table gives an overview of each carrier’s requirements to successfully activate your codes in Epic Quotes Commercial Lines.

Remove everything before the hyphen when entering the code in Epic Quotes Commercial Lines. The remaining code must be five characters, however. You will need to add a <b>0, 4, 6, or 8</b> to the beginning of the code, depending on your agency’s region.  <ul style="list-style-type: none"> <li>• 0 = Central Regional Office</li> <li>• 4 = Northeast Regional Office</li> <li>• 6 = Southeast Regional Office</li> <li>• 8 = Southwest Regional Office</li> </ul> For example, the original code provided by the agency would display as <b>MA01</b> , but for an agency in the Southeast Regional office, you would add a 6, making the code <b>6MA01</b> .

Nationwide	N/A	Eight digits. Provide your agency's five-digit code and add three leading zeros. Example: 00034567

Westfield Insurance	Email <a href="mailto:support@appliedsystems.com">support@appliedsystems.com</a> to request code verification.	Six digits. Remove the hyphen if applicable. Example: 123456 Enter email address in the <i>Username</i> field.
